- -Some small movement on non-pay
- -End of February 2021, RKE have forecasted income at being lower than what we had in the original cash flow forecast. In terms of items to be confirmed:

- -Melbury House dilapidation costs have not yet been finalised

In terms of forecast, SH commented that our predicted end position would be a higher fee income which would phase in line with the instalment and SLC payments.

5. AOB

- -Voluntary Severance Scheme: DR and TMB advised UET on a couple of cases and the potential impact for January 2021.
- -JA updated UET on the Covid cases 1 new student case in the past 7 days. Testing numbers were very similar to yesterday, around 401. Still no positive cases. JA added that there was positive progress on the January 2021 testing preparation.
- -JA advised UET that the CAF exemption which had been granted to the Facility team three years ago would expire at the end of December 2020. This was for buying low level activity on BU standard terms & conditions.

UET agreed to extend for another year and review the process during that time.
