2.1. Cash flow update

SH joined the meeting to review our latest cash flow position for this week:

- -the first tranche of the OfS capital grant income had been received. It seemed that the OfS would be paying these in two separate instalments
- -small movement on the fee income coming in earlier than expected
- -updated forecast had been received from RDS on the Research income front
- -the latest DUIT forecast had been included from the meeting last week the Digital Enablers project Manager forecasts to be further reviewed so this may be subject to change at a later date.
- -movement noted on our VAT payments which was due to timing difference on receipts received

SH added that once the November Management Accounts forecast for 2021/22 had been finalised, the cash flow would be updated to reflect this as well as the BU2025 revised cash flow forecast for future years.
