*Expecting shortly...*

- July: OfS Consultation - phase 2 quality and standards (focusing on proposed revisions to conditions B1, B2, B4, B5)
- OfS will publish TEF update on the development of the OfS' proposals (alongside the above quality consultation) and consult on a proposed new framework for TEF in autumn 2021 - at the same time as the consultation on student outcomes/phase 3 quality and standards.
- DfE/Augar related consultation(s)/Further reforms to the HE system - student finance terms and conditions, the lifelong loan entitlement, national skills fund, minimum entry requirements to higher education institutions and the treatment of foundation years (now later in 2021?!), perhaps also the modularisation of HE. Tackling low value courses is also expected to be consulted upon. Elements or all of this may be pushed back until late in 2021 (see below).
- DFE will consult on the proposals to reform FE funding and accountability.

- Consultation: new OfS strategy
- Consultation: OfS data strategy
- Consultation: review of funding for specialist providers
